**REPORT PURSUANT TO SECTION 440A OF THE MIGRATION ACT ON THE
CONDUCT OF REFUGEE REVIEW TRIBUNAL (RRT) REVIEWS
NOT COMPLETED WITHIN 90 DAYS
FOR THE PERIOD 1 JULY 2009 TO 31 OCTOBER 2009**

I provide my report pursuant to section 440A of the *Migration Act 1958* (the Act) for the period 1 July 2009 to 31 October 2009.

Section 414A of the Act sets a 90 day period for the conduct of RRT reviews of validly made or remitted applications. In accordance with section 440A of the Act, I present my report in two parts.

Part A sets out cases which were reviewed during the reporting period but which were decided outside 90 days. The reasons for reviews taking longer than 90 days are set out in four categories:

- compliance with statutory procedural requirements;
- applicant or adviser related;
- tribunal responsibility; and
- third party responsibility.

There were 695 reviews completed during the 1 July 2009 to 31 October 2009 reporting period. Of these, 247 (36%) were decided outside 90 days and 448 (64%) were decided within 90 days or were cases where the Tribunal decided it had no jurisdiction. The average number of days taken to decide reviews during the reporting period was 105 days (for those cases decided outside 90 days, the average number of days was 171, up from an average of 149 days in the previous 1 March 2009 to 30 June 2009 reporting period).

Part B sets out cases that were over 90 days and not decided at the end of the reporting period. The reasons for reviews taking longer than 90 days are set out in the same categories as in Part A.

There were 141 such cases (23%) out of a total of 607 active cases on hand on 31 October 2009.
