**REPORT PURSUANT TO SECTION 440A OF THE MIGRATION ACT ON THE  
CONDUCT OF REFUGEE REVIEW TRIBUNAL (RRT) REVIEWS  
NOT COMPLETED WITHIN 90 DAYS  
FOR THE PERIOD 1 MARCH 2011 TO 30 JUNE 2011**

I provide my report pursuant to section 440A of the *Migration Act 1958* (the Act) for the period 1 March 2011 to 30 June 2011.

Section 414A of the Act sets a 90 day period for the conduct of RRT reviews of validly made or remitted applications. In accordance with section 440A of the Act, I present my report in two parts.

**Part A** sets out cases which were reviewed during the reporting period but which were decided outside 90 days. The reasons for reviews taking longer than 90 days are set out in four categories:

- compliance with statutory procedural requirements;
- applicant or adviser related;
- tribunal responsibility; and
- third party responsibility.

There were 850 reviews completed during the 1 March 2011 to 30 June 2011 reporting period. Of these, 272 (32%) were decided outside 90 days and 578 (68%) were decided within 90 days or were cases where the Tribunal decided it had no jurisdiction. The average number of days taken to decide reviews during the reporting period was 105 days. This is the average for all 850 RRT reviews decided in the reporting period. The average for the 578 reviews decided within 90 days was 66 days. The average for the 272 reviews decided outside 90 days was 187 days.

**Part B** sets out cases that were over 90 days and not decided at the end of the reporting period. The reasons for reviews taking longer than 90 days are set out in the same categories as in Part A.

There were 294 such cases (27%) out of a total of 1,100 active cases on hand on 30 June 2011. For 2010-11 there has been an increase in RRT lodgements of 31% compared to 2009-10. As a consequence there has been a delay in constituting some cases, due to member unavailability.
