**REPORT PURSUANT TO SECTION 440A OF THE MIGRATION ACT ON THE
CONDUCT OF REFUGEE REVIEW TRIBUNAL (RRT) REVIEWS NOT COMPLETED
WITHIN 90 DAYS - FOR THE PERIOD 1 NOVEMBER 2005 TO 28 FEBRUARY 2006**

I provide herewith my report on RRT reviews pursuant to section 440A of the *Migration Act 1958* (the Act), as amended by the *Migration and Ombudsman Legislation Amendment Act 2005*, for the period 1 November 2005 to 28 February 2006.

Sections 414A and 440A of the Act, which came into operation on 12 December 2005, establish a 90 day time limit for the RRT to review applications for review of RRT-reviewable decisions and reporting obligations respectively. The 90 day time limit applies to valid applications made to the RRT and applications remitted for reconsideration by any Court.

In accordance with these requirements I present my report in two parts.

PART A

Part A sets out the valid applications for review that were lodged or applications that were remitted by a Court during the reporting period and in respect of which decisions were finalised outside 90 days.

There are five main reasons for these reviews taking longer than 90 days to complete. They are:

- delay in case allocation to Member due to backlog;
- processing of cases lodged prior to 17 June 2005;
- procedural/statutory requirements;
- further investigations or adjournments by Tribunal; and
- applicant/adviser delay.

1,122 decisions were finalised in the reporting period. 756 decisions (67%) were finalised within 90 days, while 366 (33%) were finalised outside 90 days.

Of the 366 cases, a total of 85 (22%) were lodged on or prior to 17 June 2005, when the RRT's time standard was 118 days and Members were concentrating on finalising older cases. As a result, many of these cases were not allocated to a Member at that time or were under Member review but were already more than 90 days old when the new 90 day time limit was announced.

PART B

Part B sets out RRT applications that were active and not finalised within 90 days before or during the reporting period. There were 82 such cases (an improvement of 51% from the 161 cases reported in the period 1 July 2005 to 31 October 2005). The reasons for these cases not being completed within 90 days are substantially the same as for Part A.

It is worth noting that, as at 31 March 2006, only 48 (59%) of the 82 cases were still active (34 cases having been finalised). A total of 523 cases were active before the Tribunal as at 31 March

2006 (a reduction of 623 cases from the 1,146 cases active as at 31 July 2005). 72 of these cases were older than 90 days from the date the DIMA file had been received (13.8% of active cases compared to 30.9 % of the caseload as at 31 July 2005).

Currently, there are no cases on hand that are older than 12 months. There is one case older than 9 months and there are 22 cases between 6 and 9 months old.

The RRT has been able to achieve significant improvement in the timeliness of reviews with an average processing time of 80 days for March 2006, the lowest since the RRT was established in 1993.
