**REPORT PURSUANT TO SECTION 440A OF THE MIGRATION ACT ON THE
CONDUCT OF REFUGEE REVIEW TRIBUNAL (RRT) REVIEWS
NOT COMPLETED WITHIN 90 DAYS
FOR THE PERIOD 1 MARCH 2006 TO 30 JUNE 2006**

I provide herewith my report pursuant to section 440A of the *Migration Act 1958* (the Act) for the period 1 March 2006 to 30 June 2006.

Section 414A sets a 90 day time limit for RRT reviews of validly made or remitted applications. In accordance with section 440A of the Act, I present my report in two parts.

PART A

Part A sets out the applications which were reviewed during the reporting period but which were decided outside 90 days.

The main reasons for reviews taking longer than 90 days to decide were:

- compliance with procedural and statutory requirements;
- further investigations or adjournments by the Tribunal; and
- applicant/adviser delay.

There were 712 reviews completed during the reporting period. Of these, 541 (76%) were decided within 90 days and 171 (24%) were decided outside 90 days. The average number of days taken to decide reviews during the reporting period was 83 days.

PART B

Part B sets out the applications that were over 90 days and not decided at the end of the reporting period. There were 54 such applications (an improvement of 33% from the 80 cases identified in Part B of the Principal Member's report of 12 April 2006).

The reasons for these cases not being decided within 90 days are substantially the same as for Part A.
