REPORT PURSUANT TO SECTION 440A OF THE MIGRATION ACT ON THE
CONDUCT OF REFUGEE REVIEW TRIBUNAL (RRT) REVIEWS
NOT COMPLETED WITHIN 90 DAYS
FOR THE PERIOD 1 NOVEMBER 2006 TO 28 FEBRUARY 2007

I provide herewith my report pursuant to section 440A of the *Migration Act 1958* (the Act) for the period 1 November 2006 to 28 February 2007.

Section 414A of the Act sets a 90 day period for the conduct of RRT reviews of validly made or remitted applications. In accordance with section 440A of the Act, I present my report in two parts.

Part A sets out cases which were reviewed during the reporting period but which were decided outside 90 days. The reasons for reviews taking longer than 90 days are set out in four categories:

- compliance with statutory procedural requirements;
- applicant or adviser related;
- tribunal responsibility; and
- third party responsibility.

There were 1,116 reviews completed during the reporting period. Of these, 243 (22%) were decided outside 90 days and 873 (78%) were decided within 90 days. The average number of days taken to decide reviews during the reporting period was 79 days.

Part B sets out cases that were over 90 days and not decided at the end of the reporting period. The reasons for reviews taking longer than 90 days are set out in the same categories as in Part A.

There were 85 such cases out of a total of 521 active cases on hand on 28 February 2007.
