Mr Laveta replied on 10 November 2009 and provided the following information:

I am responding to the questions you asked about [Applicant name deleted]. My answers are as follows:

A. The Riverina Fijian Community Inc. was established in 1991.

B. The first group of Fijian who want to settle down in Griffith, Leeton other towns close by.

C. A means of get together for all Fijians living in the Riverina areas.

D. Around 200 members.

E. More than 90%

F. Nearly all our members are against the illegal government which is in power in Fiji but a few of us are very active including [Applicant name deleted]. We usually meet on the second week of every month and we are affiliated to the Australian Fijian movement for democracy with a former colonel of the Fiji Military Forces as the President (Mr. Jone Baledrokadroka)

G. We have written assurances by our President Mr.Baledrokadroka and the former prime minister of Fiji that our safety is not guaranteed (Laveta, S. 2009, Email to RRT Research & Information 'RRT ref FJI35667', 10 November – Attachment 2).
